Hella marine is committed to continual improvement and alignment with international navigation light standards. As part of that commitment, we have made modifications to accommodate the changes required by the latest European and US regulations, ensuring our products meet the highest safety and performance requirements. For the NaviLED PRO this includes American Boat and Yachting Council (ABYC) C-5 Compliance for the US Market and Marine Equipment Directive (MED) approval for the European Market.

These changes have created a new look for the NaviLED PRO Port, Starboard and Stern lamps; visually, the NaviLED PRO Masthead lamps remain unchanged. Range reduction has also taken place, clear lens options are no longer available, and certifications have been amalgamated, with all lamps now being certified to the highest level.

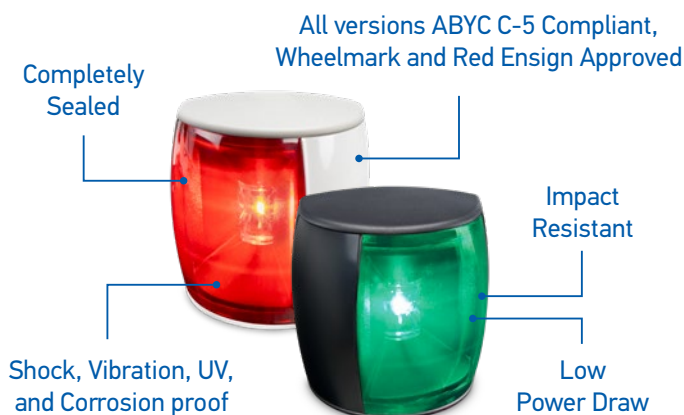

Navigation Lamps

Hella marine lamps are rated at IP67 and completely sealed. UV from the sun, corrosive salt air and constant vibration, these lamps are impervious to the marine environment.

Designed with components that suppress possible interference, both emission as well as susceptibility to emissions, to the limits prescribed in international standards. This prevents possible interference with radio, communication, navigation and other electrical equipment on board.

NaviLED PRO Port, Starboard, and Stern lamps with 2NM visibility cover vessel requirements up to 50m (164ft) LOA, while the 3NM versions cover vessel sizes greater than 50m (164ft) LOA.

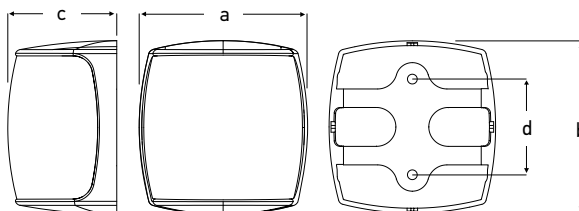
