PROPERTIES

PEVALIND PURE is a high-quality Skin Care Lotion rich in active ingredients for application after light to severe skin stress:

- ✓ is light fatty, easily spread on the skin and is absorbed very quickly.
- ✓ with consistent application, it can promote the regeneration of affected skin areas. The skin is cared for and negative environmental influences can be counteracted.
- ✓ is HACCP-rated and can therefore be used within the framework of an HACCP concept in the food industry.
- ✓ is suitable for use for people with sensitive skin.

COMPOSITION

PEVALIND PURE consists of selected, high-quality raw materials and a selection of different active ingredients:

- d-panthenol is a provitamin of pantothenic acid (Vit. B5). D-panthenol promotes wound healing, stimulates epithelisation, cell division and skin pigment build-up.*
- natural α -Bisabolol, an antiphlogistic active ingredient from chamomile. This ingredient can counteract inflammation of the skin.*
- natural free vitamin E (α -Tocopherol), with high biological activity, reduces skin damage by free radicals and thus delays the skin ageing process.*

- special moisturizers - such as ceramide precursors (Ceramide-Komplex CLR™) and sorbitol regulate the skin's moisture content and are intended to prevent excessive drying out. *
- contains natural, skin-caring almond oil.
- the use of these high-quality ingredients makes **PEVALINDPURE** an ideal skin care product of extraordinary quality.
- is pH-neutral to skin and silicon-free
- is unscented
- was rated „very good“ in a dermatological-allergological test on subjects with sensitive skin.
- has proven itself in practice based on many years of experience.

PEVALIND PURE is a white to light-yellow oil-in-water lotion, unscented.

LEGAL REGULATIONS

PEVALIND PURE is subject to the EU Cosmetics Regulation and in Germany to the Food, Consumer Goods and Feed Code (LFGB).

STORAGE INFORMATION

PEVALIND PURE can be stored in closed original containers at room temperature for at least 24 months.

SKIN CARE TIPS

In the unavoidable handling of harmful substances, a suitable skin protection product should be used to prevent skin damage before starting work (e.g. **PEVA-PERM PURE**, the generally applicable Skin Protection Lotion).

Depending on the type of soiling, a suitable skin cleansing product should be applied (e.g. **PEVASTAR** for medium to heavy soiling, or **PEVA PREMIUM** for extreme soiling).

- **PEVA ONE** - Plastic dispenser for 1 l soft bottles, with window
- **Metal Dispenser** - for 1 l bottle, with viewing window lockable
- **Plastic Dispenser** - for 1 l bottle, with transparent closure, without lock
- **Plastic Dispenser** - for 1 l bottle, screwable, with and without wall holder
- **VOORMATEC SF2** - plastic dispenser for 1 l and 2 l soft bottles, white or silver lacquered cap
- **PEVAMAT SF** - stainless steel dispenser for 1 l and 2 l soft bottles, white cap, powder coated, with and without lock
- **PEVA** - 3-piece dispenser set for every bottle skin protection, skincare and for a 3 l can hand cleaner, with wall holder and dispenser pumps
- **PEVAMAT Care&Clean Dispenser** - for 1 l bottle, manual/touchless
